**RESOLUTION 2021-0801**

**A RESOLUTION OF THE BOARD OF ALDERMEN OF THE CITY OF LAKE ANNETTE, MISSOURI TO REQUEST ALLOCATION OF LOCAL FISCAL RECOVERY FUNDS THROUGH THE AMERICAN RESCUE PLAN ACT OF 2021.**

**WHEREAS**, on March 11, 2021 the President of the United States signed into law the American Rescue Plan Act (APRA) to provide continued relief from the impact of the Covid-19 pandemic (“Pandemic”); and

**WHEREAS**, approximately \$18,420 will be allocated to the City of Lake Annette (“City”) pursuant to the ARPA (“Allocation”); and

**WHEREAS**, the United States Department of Treasury has adopted guidance regarding the use of ARPA funds; and

**WHEREAS**, the City in response to the Pandemic, has had expenditures and anticipates future expenditures consistent with the Department of Treasury’s ARPA guidance; and

**WHEREAS**, the State of Missouri will distribute ARPA funds to the City because its population is less than 50,000.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Aldermen of the City of Lake Annette, Missouri, as follows:

**Section 1:** The City intends to collect its share of ARPA funds from the State of Missouri to use in a manner consistent with the Department of Treasury’s guidance.

**Section 2:** City Clerk, together with the Mayor are hereby authorized to take any actions necessary to receive the City’s share of APRA funds from the State of Missouri for expenses incurred because of the Pandemic.

**Section 3:** City Clerk, together with the Mayor and Board of Aldermen are hereby authorized to make recommendations to the Board of Aldermen for future expenditures that may be reimbursed with APRA funds.

**Section 4:** That a copy of this resolution shall be kept on file in the office of the City Clerk.


**Section 5: Effective Date.** This resolution shall become effective upon its approval.


