ORDINANCE 2025-2006

AN ORDINANCE OF THE BOARD OF ALDERMEN OF THE CITY OF LAKE ANNETTE, MISSOURI, TO START REQUIRING BUSINESS LICENSES FOR BUSINESSES WITHIN CITY LIMITS, AS ALLOWED BY RSMO. 94.270.

WHEREAS, the City of Lake Annette, Missouri desires to start requiring Business Licenses for businesses within City limits; and

WHEREAS, the City desires to have a flat fee for business licenses in the amount of fifty dollars (\$50.00) that will be valid for one (1) year, to be renewed each July.

NOW, THEREFORE BE IT ORDAINED, BY THE BOARD OF ALDERMEN OF THE CITY OF LAKE ANNETTE, MISSOURI AS FOLLOWS:

- Section 1.** That City Staff is hereby directed to require Business Licenses for Businesses with City limits, as allowed by RSMo. 94.270.
- Section 2.** That said Business License fee shall be in the amount of fifty dollars (\$50.00) and shall be valid for one (1) year, to be renewed each July.
- Section 3.** If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
- Section 4.** A copy of this ordinance shall be kept in file in the office of the City Clerk.
- Section 5.** All ordinances in conflict herewith are hereby repealed.
- Section 6.** That the City Clerk is authorized by this Ordinance to correct any scrivener's errors identified within this Ordinance.

Section 7. Effective Date. This Ordinance shall be in full force and effect immediately upon its execution by the Board of Aldermen of the City of Lake Annette, Missouri.


