ORDINANCE NO. 2025-2008

AN ORDINANCE OF THE BOARD OF ALDERMEN OF THE CITY OF LAKE ANNETTE, MISSOURI CERTIFYING THE RESULTS OF THE APRIL 8, 2025, MUNICIPAL ELECTION.

WHEREAS, A General Municipal Election was held in and for the City of Lake Anette, Missouri on Tuesday, April 8, 2025.

NOW, THEREFORE BE IT ORDAINED, BY THE BOARD OF ALDERMEN OF THE CITY OF FREEMAN, MISSOURI AS FOLLOWS:

SECTION 1. It is hereby found and determined by a canvass of the votes by the Board of Aldermen of the City of Lake Anette, Missouri, at the election held on April 8, 2025, in conformity with the Revised Statutes of Missouri and Ordinances of the City of Lake Anette as Follows:

SECTION 3. That a copy of this ordinance shall be kept on file in the office of the City Clerk.

SECTION 4. That all ordinances in conflict herewith are hereby repealed.

SECTION 5. Effective Date. This Ordinance shall be in full force and effect immediately upon its execution by the Board of Aldermen of the City of Lake Annette, Missouri.


