**Ordinance No. 2025-2015**

**AN ORDINANCE OF THE BOARD OF ALDERMEN OF THE CITY OF LAKE ANNETTE, MISSOURI CALLING FOR A GENERAL MUNICIPAL ELECTION OF THE OFFICERS OF THE CITY OF LAKE ANNETTE, MISSOURI, TO BE HELD ON APRIL 7, 2026, AND FOR PROVIDING NOTICE TO THE GENERAL PUBLIC.**

**WHEREAS**, state election laws require that the City of Lake Annette call for an election of officers to be conducted on April 7, 2026; and

**WHEREAS**, the terms of At Large Alderman Robert Lampkin, and At-Large Alderman Edna Burns expire upon said election.

**NOW THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF LAKE ANNETTE, MISSOURI AS FOLLOWS**

**Section 1** – The annual election of the officers of the City of Lake Annette, Missouri, shall be held on April 7, 2026, in conformity with Section 79.030 RSMo 2000. At said election there shall be elected:

2 members of the Board of Aldermen at-large for the full term of two (2) years.

**Section 2** – All persons aspiring to the election of such offices and desiring to be candidates for such office, and all persons desiring their names to be and appear as candidates for such offices upon the city ticket of the election aforesaid, shall file their names within the City and with the City Clerk of Lake Annette, Missouri at her office in the City Hall at 106 E. Main Street, Freeman, Missouri. Filing shall commence on:

December 9, 2025, at 8:00 a.m.

And shall close on

December 30, 2025, at 5:00 p.m.

The Office of the City Clerk will not be open Fridays, Saturdays or Sundays, or those days declared a holiday by the City of Freeman.

**Section 3 - Persons** who, after filing their names as candidates with to withdraw as such candidates must file their notice of withdrawal with the City Clerk in her office not later than 5:00 p.m. on December 30, 2025.

**Section 4** – Before December 9, 2025, the City Clerk shall notify the general public of the opening filing date, the offices to be filled, the proper place for filling and the closing filing date of the election, all pursuant to and in conformance with RSMo. Sec 115.127.5.

**Section 5** – That a copy of this ordinance shall be kept on file in the office of the City Clerk.

**Section 6** – That all ordinances in conflict herewith are hereby repealed.

**Section 7 – Effective Date.** This ordinance shall be in full force and effect from and after the date of its passage and approval.
