AN ORDINANCE OF THE BOARD OF ALDERMEN OF THE CITY OF LAKE ANNETTE, MISSOURI CERTIFYING THE RESULTS OF THE APRIL 7, 2026, MUNICIPAL ELECTION.

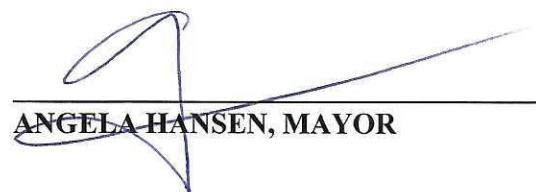
